

Mid Sussex District Plan 2014 – 2031 Main Modifications to the District Plan Consultation Form

The District Council is seeking representations on a schedule of Main Modifications to the District Plan 2014 – 2031, which sets the strategic framework for development in Mid Sussex over the next 17 years.

Following the Examination Hearings, the council has prepared some Main Modifications to the Plan for public consultation. The Main Modifications are changes, additions or deletions to make the plan 'sound' and have been prepared in liaison with the Planning Inspector during the course of the Examination.

At this stage, representations are only being sought on whether the Main Modifications to the Plan are sound and /or legally compliant. Comments will only be accepted if they relate to a Main Modification listed in the accompanying schedule, the Sustainability Appraisal, or Habitats Regulations Assessment.

All comments submitted will be considered by the Planning Inspector, appointed by the Secretary of State.
