Minutes of the Planning Committee meeting held on Monday 8 October 2012 at 7.30 pm in the Parish Centre, Adastra Park, Hassocks.

There were 4 members of the public present.

- **1. Apologies for Absence.** An apology for absence was received from Penny Wadsworth.
- 2. Declarations of Interest. There were no declarations of interest.

The meeting was adjourned for public participation. Sian Philips spoke against application HA/12/03165/TREE on the grounds that the Holm Oak is a living green landmark and that Network Rail have not been asked to look at alternative sites for the lift shaft. Margaret Ford Chairman of the HAA, Catherine Cassidy, Chairman HAA Rail Group and Linda Dyos of Fulking Parish Council and the Rail Group all spoke in favour of the application stating that although they agree that it is regrettable that this fine tree and roosting site for wagtails should be removed, it is necessary to balance this against the needs of the wider community. Hundreds of people find the steps to the underpass impossible or very difficult and from an engineering point of view it would be very difficult to place the lift shaft elsewhere and the opportunity of this massive investment in our local infrastructure should not be lost. Network Rail has agreed to replace the tree once the work is complete.

3. Minutes of the meeting held on 17 September 2012. The minutes were taken as read, agreed as a correct record, and signed by the Chairman as a correct record.

Holly Tree – Thin by 30% and remove lower branches.

Response: recommend refusal. This is a fine Holly Tree in good health. It is considered that crown thinning would be detrimental to the shape of the tree.

The Tree Warden has suggested to the applicant that she submit a new application for crown lift and reduction.

Proposed single storey to rear. Response: recommend approval.

1 Holly – Cut back by 1m and reshape Response: Recommend approval.

Replace wooden and aluminium windows with UPVC.

As a consequence he is preparing instructions for a breach of condition notice to be issued. It was noted that of the existing bollards, one is missing and one is damaged.
- 8. Grand Avenue Traffic Calming. Nothing further to report.
- **9. Jack Mill.** The email from Alma Howell of MSDC, dated 24 September 2012 was noted. The Assistant is to write to Alma Howell thanking her for the progress and for keeping us informed.
- **10. Clayton Mills.** Steve Ashdown's email response to the Parish Council's concerns regarding the maintenance of the balancing pond and the landscaping of the open space to the north of the development was noted. This item is to remain a standing item on the agenda.
