Proposed Submission Draft West Sussex Joint Minerals Local Plan - Update

West Sussex County Council and the South Downs National Park Authority are working in partnership to prepare a new Joint Minerals Local Plan for West Sussex. On adoption, it will replace the current West Sussex Minerals Local Plan that was adopted in 2003.

Comments received during the 9-week consultation on the draft West Sussex Joint Minerals Local Plan during April – June 2016 have now been analysed and further technical work has taken place on transport and landscape issues, mineral resources, and sustainability appraisal. A number of changes have been made to the Plan to take account of comments received on the draft Plan and the outcomes of this further technical work.

The Authorities are now preparing to publish the revised Plan, which will be known as the **Proposed Submission Draft West Sussex Joint Minerals Local Plan**, alongside the evidence base which has been prepared to support the Plan. Members of the County Council and the South Downs National Park Authority will consider the Proposed Submission Draft West Sussex Joint Minerals Local Plan at the following meetings:

period between January and March 2016; this is under Regulation 19 of the Town and Country Planning (Local Planning) (England) Regulations. We will write to you again in early 2017 to confirm the start of the representations period.

Following consideration of the representations, and subject to the scope of any amendments required to the Plan, a submission draft version of the Plan will be prepared and submitted to the Secretary of State for an independent examination by a Government appointed Planning Inspector.



- Proposed Warning Signs Adjustments

1. The purpose of this report is to inform the Committee on correspondence received from West Sussex County Council (WSCC) regarding proposed 'School' warning sign adjustments.

- 2. As part of the continuous road safety improvement programme at schools across West Sussex the warning signs at this site have been reviewed and WSCC welcome comments on the attached proposals.
- 3. It is proposed to provide 'School' warning signs with associated flashing light units in Keymer Road, replacing the existing Patrol signs, and signs without flashers in Chancellors Park. The flashing units will be programmed to activate during term time at school drop off / pick up times.
- Attached are draft details for information / comment and it is proposed that detailed designs will be prepared for installation during next financial year. Any comments on the proposals are to be received by the 15th December.
