3. The minutes of the meeting on 10<sup>th</sup> December 2015 were approved as an accurate record of the meeting.

- 2. IC was unaware as to whether GO had investigated whether the Vicar of the United Reform Church had heard back from WSCC.
- 3. IC and DM had drafted and sent a letter regarding what information the Parish Council hoped would be in the feasibility study.

- 13. LB was under the impression that FG had been copied into the revised map.
- 14. A planning response had been drafted regarding the Gleeson Appeal and this had been sent to MSDC by the Planning Committee.

- 4. Publication of Regulation 14 Pre Submission Draft Plan.
  The Draft Reg. 14 Plan had been published and well-advertised. IC thanked all for their huge effort to enable this to be achieved and later in the meeting IW thanked the Working Group on behalf of the Parish Council.

5. Correspondence.

IC had received some correspondence from the Mackie Avenue Residents' Committee to which he had replied. IC read out the letter that had been sent after approval from the correspondence approval group. In summary the Resident's Association didn't believe they had been consulted sufficiently and IC had pointed out that there were no Statutory Consultees during the production of the Neighbourhood Plan and only at Reg. 14. Consultation stage and the obligations at this stage had been met. A reply had been received and the standard response that the comments would be taken into account for the production of the Final Plan was to be made. The points raised would be addressed in the Consultation Document to accompany the final Reg. 15 Plan. IC mentioned at the meeting that never- the- less the Working Group had sought to Consult with stakeholders along the process of producing the Neighbourhood Plan on two occasions and at each occasion Residents from Mackie Avenue had been present, particularly the second Consultation in July when 76 residents of Mackie Avenue had attended.
