Subject: Hassocks Infants School - Proposed School Warning Sign Adjustment

 The purpose of this report is to update members on comments from the Project Officer responsible for the Hassocks Infant School proposed Warning Signs Adjustments, in response to comments previously submitted by the Planning Committee.

- 2. Planning Meeting 12.12.16. Minute Ref: 564.2 The Committee considered the amended proposals and concurred with the value of the illuminated signs on Keymer Road either side of Hassocks Infant School. However the question was raised as to why an additional illuminated sign was not to be placed on Grand Avenue on the approach to the junction of Keymer Road and the location of the school crossing patrol. The Committee were not clear as to the value of the additional warning signage to be placed in Chancellors Park
- 3. Additional illuminated sign in Grand Ave -
- 4. Response from WSCC Vehicles in Grand Ave are required to give way at the junction so will be reducing speed as they approach so it is not felt that an illuminating sign would provide additional benefit. It was noted that the existing warning / Patrol sign in Grand Ave is partially obscured by trees and probably more so in the summer months. It may be possible to relocate this sign and combine it with the bus stop sign near to number 2 Grand Ave and closer to the junction with Keymer Road. However this may lead to a complaint from the local resident. We will investigate further.
- 5. Signs in Chancellors Park -
- 6. Response from WSCC Apart from the keep clear road marking the entrance / exit to the school is not well defined from a drivers perspective therefore we recommend that these signs are provided.
- 7. The Committee is invited to note the above responses and to consider whether it wishes to make any further comments on this matter.

# Publication of the Proposed Submission Draft of the West Sussex Joint Minerals Local Plan (Regulation 19)

In partnership, West Sussex County Council and the South Downs National Park Authority have prepared a Joint Minerals Local Plan which includes strategic mineral site allocations.

The responses received to the "Have your say on the Minerals Local Plan" consultation during Spring 2016 (under Regulation 18), as well as further technical work, have informed the preparation of the Proposed Submission Draft of the Joint Minerals Local Plan.

The draft Joint Minerals Local Plan has four key areas:

- A vision and 'strategic objectives' for future mineral development in West Sussex.
- Ten 'mineral and use-specific' policies which will achieve the strategic objectives for different mineral activities (policies M1-M10).
- Fifteen 'development management' policies which will ensure that there would be no unacceptable harm to the environment and communities of West Sussex (policies M12-M26).
- Two mineral site allocations which will help make an important contribution to meeting the need for minerals (Policy M11):
  - Ham Farm, near Steyning (soft sand)
  - Land adjacent to West Hoathly Brickworks, West Hoathly (brick clay)

The draft plan has been published prior to its submission to the Secretary of State to allow representations to be made on its 'soundness' and 'legal compliance'.

Representations can be made up until 5pm on Monday 13 March 2017.

Following this period, the Plan and supporting evidence base, and the representations received will be considered by a Government-appointed Planning Inspector, at an examination-in-public to be held in summer 2017. Once adopted, the Joint Minerals Local Plan will provide the basis for making consistent land-use planning decisions about planning applications for minerals development.

Accompanying this letter is a 'Statement of Representation Procedures' which sets out details of the representations period and where documents can be obtained, including Representation Forms and Guidance Notes on how representations are to be made.

# West Sussex Joint Minerals Local Plan: Proposed Submission Draft

Following a period of informal public consultation on the Draft West Sussex Joint Minerals Local Plan (JMLP), held from 14 April to 17 June 2016, West Sussex County Council and the South Downs National Park Authority have published the Proposed Submission Draft of the JMLP for formal representations.

The purpose of the representations period is to allow local communities and other interested parties the opportunity to submit representations about whether the JMLP is 'sound' (that is, it has been positively prepared, it is justified, it is effective, and it is consistent with national policy), and that it is legally compliant.

Following completion of the representations period, the JMLP will be submitted to the Secretary of State to undergo an Examination-in-Public by a Government-appointed Inspector. Following the examination, the Inspector will produce a report determining whether or not the plan is sound.

**Document Title:** West Sussex Joint Minerals Local Plan: Proposed Submission Draft

**Subject matter and area covered:** The Proposed Submission Draft sets out the background, the spatial context, strategies and policies to enable the delivery of sustainable mineral development for the period up to 2033. The plan includes site allocations and is supported by a Key Diagram and Inset Maps.

Once adopted, the JMLP will replace the saved policies in the adopted West Sussex Minerals Local Plan 2003.

The area covered is the administrative areas of West Sussex County Council, as well as the portion of the South Downs National Park Authority that lies within West Sussex.
