1. The purpose of this report is to update the Committee on Grounds and Environment (G&E) Matters.

2. Update on Matters from G&E Meeting held on 30 January 2017.

Bus Shelter Cleaning Contract. The two bus shelters on London Road are now being cleaned on a monthly schedule.

Parklands Road Allotments.

<u>Fencing</u> The cost of Palisade fencing is being explored for the entire boundary of the Parklands Road Allotments and also a cost is to be explored for palisade fencing to be installed just at the most vulnerable areas in the existing fencing.

<u>Oak Tree</u> There is some question as to whether the Oak Tree discussed is still in good health, therefore it has been decided that it would be advisable to inspect the tree when it comes back into leaf before making any further decisions on it.

3. ADASTRA COMMUNITY PAVILION.

<u>Adastra Pavilion Flooring</u>. The new flooring in the Pavilion has been laid and four new barrier mats have been put in place. Users have been asked to be considerate when entering the building with muddy footwear, and have been asked to remove any footwear with spikes or studs before entering the main hall.

4. ADASTRA BOWLING GREEN.

A leak was discovered in the irrigation system of the bowling green. This was located and exposed by the Grounds team of Adastra Bowls Club and repairs were carried out by the contractor who has carried out previous repairs to the system. The ground was re-instated by the Grounds Team. The cost of the repair is £325.00 plus VAT

2. Correspondence has been received as follows:

As part of the 25th anniversary celebrations to be held on Saturday 3rd June Hassocks Twinning Association would like to have the Mayor and Burgermeister of our twin communities plant a tree in the southern field as a mark of friendship and to be a lasting monument to the relationship. The Chairman or a representative of the PC would be involved from Hassocks' side.

We would like your permission and perhaps some guidance as to where the Council might think suitable/permissible and what size and species might be allowed.

We have funds and can provide a tree. The ceremony would form part of the Celebrate Hassocks event to be held on Adastra Field and in the Hall that day.

We look forward to your response.

3. To inform the Committee further a report is included below from the Tree Warden with suggested possible locations and suitable trees for planting.

I was able to identify 3 possible sites:

- 1. Opposite the Council Office between the Bins and the very large oak I would suggest for here a small/medium tree—A Rowan or Mountain Ash—Sorbus Aucuparia.
- 2. Beyond the Skateboard area on the grassed area gently sloping to the north—This could take a large tree—I would suggest a Pin Oak—Quercus Palustris -- wonderful autumn colours .
- 3. In far south east corner-here I would suggest the same as 1. above .

Both these trees are readily sourced and are recommended as Parkland trees .

I have thought about the potential vandalism problem and think 2. above is probably the most vulnerable.
