- A Development Viability SPD, which provides information on the viability assessment process.

The three draft SPDs were considered by the Scrutiny Committee for Community, Housing and Planning on the 21st March 2018. Following the public consultation, the revised draft SPDs were considered by the Scrutiny Committee for Community, Housing and Planning on the 4th July 2018.



West Sussex Minerals & Waste Planning Policy: Summer Update.

Adoption of the Joint Minerals Local Plan

In partnership, West Sussex County Council and the South Downs National Park Authority have prepared a Joint Minerals Local Plan (JMLP). The Authorities received the Planning Inspector's Report on 30 May 2018 and the JMLP has been found **sound** subject to a number of modifications.

The Inspector's Report and modifications recommended by the Planning Inspector were considered by the South Downs National Park Authority on 3 July 2018 and by West Sussex County Council on 20 July 2018. Both Authorities resolved to adopt the JMLP with effect from 20 July 2018.

Accordingly, the adopted Plan is now part of the statutory 'Development Plan' for West Sussex (both inside and outside the National Park) and will be the basis for all planning decisions relating to mineral development in the County.

If you would like to view the adopted JMLP, and the accompanying Sustainability Appraisal, they are being made available for inspection at the main deposit point locations, details of which are set out in the enclosed Adoption Statement. They are also available on our website, www.westsussex.gov.uk/mwdf.

Joint Minerals Local Plan: Single Issue Soft Sand Review

Policy M2 of the JMLP sets out a requirement for the Authorities to undertake a single issue soft sand review of the Plan. Work on this review has begun, in line with the timetable set out in the recently approved Minerals and Waste Development Scheme. The review is addressing the strategy to maintain a steady and adequate supply of soft sand, the supply and demand for soft sand, and the approach to meet any shortfall, including the potential need to allocate sites.

Public consultation on issues and options is scheduled for early 2019. We will update you later in the year about progress with the review.

Consultation on the Draft West Sussex Statement of Community Involvement (Third Review)

The Second Review of the West Sussex Statement of Community Involvement (SCI) was published in June 2012. The SCI is a formal statement of the County Council's policy on how local communities and stakeholders can be actively, meaningfully and continuously involved in the preparation of local plans, and the consideration of planning applications that the County Council is responsible for determining.

The Town and Country Planning (Local Planning) (England) (Amendment) Regulations 2017 requires that SCIs are reviewed every five years. The County Council has reviewed the SCI and prepared a draft, which is being consulted upon for a period of six weeks, ending on **Friday 7 September 2018**. The draft SCI is available on our website at www.westsussex.gov.uk/mwdf.

Please note that the South Downs National Park Authority has its own SCI and that this consultation is solely on the County Council's SCI.



West Sussex Joint Minerals Local Plan

Notice of Adoption of Local Plan (Regulation 26)

Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended)

In accordance with the Regulations set out above, this Adoption Statement gives notice that West Sussex County Council and South Downs National Park Authority formally adopted the West Sussex Joint Minerals Local Plan on 20 July 2018.

The West Sussex Joint Minerals Local Plan is the principal document for the determination of applications for minerals activities (both inside and outside the National Park). The Plan covers the period to 2033, and sets out the background, the spatial context and the strategy and policy context within which it has been prepared. It includes a vision and strategic objectives, land-use strategies, use-specific and general development management policies, the allocation of a mineral site, and implementation and monitoring information.

The Plan was subject to an Examination in Public, by an independent planning inspector, during September 2017. The Planning Inspector issued his report on 30 May 2018, and deemed the Plan to be sound and legally compliant, subject to modifications. The adopted Plan incorporates the Main Modifications, and a number of minor modifications.

Any person aggrieved by the Plan may make an application to the High Court under the Planning and Compulsory Purchase Act 2004 section 113 on the ground that;

(a) the Plan is not within the appropriate power;

(b) a procedural requirement has not been complied with.

An application must be made no later than the end of the period of six weeks starting from the date the Plan was adopted. The period ends on **31 August 2018.**

The Plan cannot be questioned in any legal proceedings except in so far as is provided by section 113.
