

# Hassocks Village Action Plan

**December 2002** 



## Preface

Hassocks Village Action Plan was started on February 6th 2001 when a Steering Group was formed from village organisations and the Parish Council. New members joined later as a result of a public meeting. The project received great help and encouragement from the Sussex Rural Community Council (now known as Action for Rural Sussex) and from the Hassocks Regeneration Partnership, which provided an organisational base.

At a public meeting on April 2nd 2001, themes were identified that could be explored further in a village questionnaire. Five task groups met to work out the details.

The questionnaire was finalised by the end of July and delivered to 3300 homes in October. It included 48 questions related to the Village Action Plan and 25 questions for Centuri21 (a pilot project to do with using IT to improve information and communication about public services in rural communities). There was a separate Young People's questionnaire and an opportunity to volunteer to help with village activities.

917 completed questionnaires were received, representing 1692 respondents, and there were 114 responses to the young people's questionnaire. Brighton University students input the 'tick-box' data and members of the Steering Group collated the 'written-in' answers. Initial computer analysis was completed by the end of February 2002 and the task groups were then re-activated to suggest an action plan. The action plan attached is a result of the discussions of these groups and of the whole Steering Group and finally with the Parish Council, which approved the plan on December 10th 2002.

## Finance

Printing and delivery of the questionnaire was funded by the Hassocks Regeneration Partnership, Mid Sussex District Council, and Centuri21. The Countryside Agency made a grant of up to £3,300 under the Parish and Town Plans scheme against a budget of £4,400 for data analysis and publication of the results.

# Rail Services

### **Action I** To improve the train service to Hassocks

- re-introduce off-peak to London Victoria services
- increase weekend service
- introduce Sunday Thameslink
- restore late-night services from Brighton on Friday and Saturday
- introduce a shuttle service to Gatwick
- introduce more direct services to Hove

- **how** Lobby the train companies
  - Hold co-ordination meeting with other groups
  - Act as contact point for railway users
